ACTION TAKEN:

On 10/03/13 at approximately 1400 hours, this Detective and Det. Mugavin arrived at "Shooters indoor pistol range" located at 146 Danbury Road in New Milford, Connecticut. The purpose of this visit was to review the range sign-in sheets for the year 2011 pursuant to information developed in the [REDACTED] 29, CFS12-00 [REDACTED] 29

That during this review, this Detective found a sign-in sheet dated 02-18-11. On this sign-in sheet for the range, Nancy Lanza and the shooter signed in at 4:30pm. Nancy provided her permit number of 967129, and a sign out time of 5:05pm. The shooter did not sign out, but this appears to be an omission, as many of the other people on the sheet did not provide a sign out time. (See attached copy).

The owner of this business Dick Giannettino (DOB [REDACTED] 03) was advised of the situation and he turned over copies of this sign-in sheet in addition to two other sign-in sheets related to the [REDACTED] 29. Giannettino told this Detective that during the Sandy Hook investigation, the ATF had gone through the sign-in sheets, but he was not sure if they looked as far back as 2011. Giannettino stated that he was not sure what they had reviewed, but they must have just missed this one.

Another employee Erika Jones (DOB: [REDACTED] 03) also assisted this Detective review sign-in sheets for the [REDACTED] 29
