DATE AND TIME: On 10/16/13 from approximately 0910 hours to approximately 0945 hours.

LOCATION: This interview was conducted in the Adult Probation Office located at 319 Main St. in Danbury, CT.

ACTION TAKEN:

On 08/16/13, I was assigned to review documents returned from the FBI-Behavioral Analysis Unit. A review of box #3 of 5 boxes revealed a spiral bound booklet called "The Big Book of Granny", which appeared to be created by the shooter and **04**. The book is bound in a black plastic spiral binding and covered on the front and back with a clear plastic sheeting.

On 10/16/13 at approximately 0900 hours, Det. Van Ness and I met at the office of 04 Probation Officer, Henry Wardowski, at 319 Main St. in Danbury, CT. Wardowski stated that he was recently assigned to supervise 04 stemming from a court case involving motor vehicle charges.
