
On the above-mentioned date and time, I c	onducted a pre-arranged telephone interv	iew with 04 . When I asked he	er about her specific "smile"
comment mentioned above, she stated that	t it wasn't based upon any specific reason	ing, just instinct. I then asked he	r about her knowledge of the
shooter based upon	04	and any	other means, whereupon
04 informed me of the following:	04 as well as one or two	o other kids 04	as the shooter and his
older brother Ryan. The shooter didn't con	nect with anyone at all. He was not bullier	d, however he was just left alone.	He never associated with
others and 04 he wou	ld simply sit with his headphones on and li	isten to loud Techno music. She	tried to be nice to him by
saying "hi" and things but the shooter woul	dn't even make eye contact with others. T	The only time that she remembers	him looking directly at her was
once when the shooter seemed to be angr	y and he told her that he would "bomb" he	r. 04 still never thought that h	e would do anything like this.
He just remained extremely detached. Rya	an was also not too interactive with others	but he was not totally disassociat	ted. Ryan would at least
exchange "hellos" and pleasantries.	04 encouraged her to be nice to the L	Lanza family and	04
however the brothers of	only came once. Nancy Lanza came to the	eir house several times and seen	ned convinced that the shooter
was sick somehow. Nancy would talk about	ut whoever she was dating at the time, her	clothing and the shooter, including	ng how brilliant he was and a
story about him hacking into computers. T	he one time that Ryan and the shooter	04	they both immediately
went to the basement and played video ga	mes (possibly Halo), so 04 didn't intera	act with them.	
04 also stated that the Lanzas had a wi	reless network that was not password pro	tected. She said that it was name	ed "Night Elf", which she later
learned probably referred to a World of Wa	arcraft character. She further stated that v	when her family heard the initial re	eports that Ryan was the
shooter, they knew that Ryan wouldn't have	e done that and that it must have been his	brother. 04 also said that	04 had conversations with
Nancy Lanza about the shooter as well, bu	it that 04 was unsure if	would be comfortable	e talking to police. I asked her


