DATE AND TIME OF INTERVIEW:

Tuesday, October 22nd, beginning at approx. 1930 hrs. and ending at approx. 2000 hrs.

During an earlier 04 interview with 04, she stated that 04 had mentioned that she 04 could picture the shooter doing this (the shooting) with a smile on his face (refer to Interview Report - 04). In light of this information, I contacted 04 and explained to her that I wanted to speak to 04 to ask her to elaborate on that information. 04 informed me that 04 was also in some classes with the shooter. 04 also explained that 04 might be apprehensive about talking about the shooter because of the effect that the shooting has had on them. She agreed to talk to them and if they were comfortable, they would reach out to me. 04 then contacted me and we set up a time for this telephone interview.

ACTION TAKEN:

On the above-mentioned date and time, I conducted a pre-arranged telephone interview with 04. When I asked her about her specific "smile" comment mentioned above, she stated that it wasn't based upon any specific reasoning, just instinct. I then asked her about her knowledge of the shooter based upon [Redacted] 04 and any other means, whereupon 04 informed me of the following: [Redacted] 04 as well as one or two other kids [Redacted] 04 as the shooter and his older brother Ryan. The shooter didn't connect with anyone at all. He was not bullied, however he was just left alone. He never associated with others and [Redacted] 04 he would simply sit with his headphones on and listen to loud Techno music. She tried to be nice to him by saying "hi" and things but the shooter wouldn't even make eye contact with others. The only time that she remembers him looking directly at her was once when the shooter seemed to be angry and he told her that he would "bomb" her. 04 still never thought that he would do anything like this. He just remained extremely detached. Ryan was also not too interactive with others but he was not totally disassociated. Ryan would at least exchange "hellos" and pleasantries. [Redacted] 04 encouraged her to be nice to the Lanza family and [Redacted] 04 however the brothers only came once. Nancy Lanza came to their house several times and seemed convinced that the shooter was sick somehow. Nancy would talk about whoever she was dating at the time, her clothing and the shooter, including how brilliant he was and a story about him hacking into computers. The one time that Ryan and the shooter [Redacted] 04 they both immediately went to the basement and played video games (possibly Halo), so 04 didn't interact with them.

04 also stated that the Lanzas had a wireless network that was not password protected. She said that it was named "Night Elf", which she later learned probably referred to a World of Warcraft character. She further stated that when her family heard the initial reports that Ryan was the shooter, they knew that Ryan wouldn't have done that and that it must have been his brother. 04 also said that 04 had conversations with Nancy Lanza about the shooter as well, but that 04 was unsure if 04 would be comfortable talking to police. 04 also expressed concern for 04 because of all the attention and unusual activity that there has been since the shooting. She stated that the Newtown Police have been called several times because of 04
