WITNESS INTERVIEW REPORT: [REDACTED] 04

On November 15th, 2013, from approximately 1001 hours to 1030 hours, Det. Downs and I met with witness, [REDACTED] 04, within the living room of his residence located at [REDACTED] 04, 03 to obtain a statement pertaining to the Sandy Hook school shooting. [REDACTED] 04 stated verbally and later in a sworn written statement that he had met Nancy Lanza approximately 10 years ago at My Place restaurant in Newtown, CT. [REDACTED] 04 described the atmosphere within the restaurant as "friendly" which is how he got to know Nancy. Approximately 5 years ago, [REDACTED] 04 was telling Nancy about a problem that he was having with his MAC computer running on Windows. He brought this up because in the past, Nancy had told him how her son enjoyed fixing computers. Shortly after their conversation, Nancy drove her son to [REDACTED] 04 residence. [REDACTED] 04 greeted the Lanzas at his door and shook the shooter's hand (During conversation that Nancy had with [REDACTED] 04 she stated that during their drive, the shooter contemplated whether to shake hands or not with [REDACTED] 04. The shooter worked on the computer for about an hour while Nancy and [REDACTED] 04 had casual conversation elsewhere. The shooter then stated that he needed to take the computer to his residence because he had more effective tools to fix the problem, which he did. During [REDACTED] 04 brief interactions with the shooter, he described him as being very polite but [REDACTED] 04 had to ask questions to get any response. This was the first and only interaction he had with the shooter.

[REDACTED] 04 recalls getting his computer back from Nancy during a night out at My Place. The shooter left a note with the computer describing what he did to fix the problem. [REDACTED] 04 wanted to pay the shooter for his services but payment wasn't excepted because the shooter simply enjoyed working on them. Nancy instead asked [REDACTED] 04 to write a letter of reference for the shooter which he did. During conversation that [REDACTED] 04 had with Nancy she spoke of the shooter's issues: Aspergers Syndrome, how he didn't like to be touched and didn't show much interest in learning to

Nancy also stated that the shooter was intelligent, enjoyed indoor saltwater swimming somewhere in Brookfield, enjoyed bicycling and took courses in shooting and target practice which the shooter was proficient at. From time spent with Nancy, [04] is confident in stating that Nancy was very caring about her 2 sons.

The last time that [04] saw Nancy was approximately 3 to 6 months before she died (See attached copy of statement for details.)
