DATE AND TIME: On 12/15/12 beginning at 1846 hours and ending at approximately 1914 hours.

LOCATION: This interview was conducted at the dining table at [REDACTED] **03, 04**

**ACTION TAKEN:**

On 12/15/12, I was assigned to interview **04** regarding his previous encounters with Adam and Nancy Lanza. I responded to **04** residence accompanied by Detective Kiely #905 and were greeted at the front door by **04** invited us into his home and asked us to sit at his dining table to conduct the interview. After obtaining a brief verbal account of his interaction with Adam and Nancy Lanza, **04** provided a written statement. The following is a summary of the statement provided by **04**

04 stated that he retired 04 years ago and moved to 04. He stated that approximately 3-4 years ago, he met Nancy Lanza at "My Place" restaurant. He stated that they began discussing guns due to his past employment as a police officer. He stated that Nancy mentioned that she had a .45 caliber handgun in New Hampshire and that she wanted to bring it to her home in Connecticut. 04 stated that he told her that she would need to get a permit to move the gun and Nancy asked him if he wanted to purchase the gun. 04 stated that he was at the Wooster Mountain Shooting Range in Ridgefield (Danbury) approximately 2 years ago. He stated that he saw Nancy and Adam there shooting the Bushmaster AR-15 as well as what he believed to be a Glock Model 19 .9mm handgun. 04 stated that Nancy asked him if he would be willing to give Adam some pointers and tips on how to shoot. 04 stated that he agreed and gave Adam a quick lesson in controlling his breathing and proper aiming techniques. 04 stated that Adam was a quiet guy who didn't talk much. He stated that Adam listened well and did as 04 told him. He stated that was the only time that he ever shot with Adam or Nancy. 04 stated that Nancy told him that she and Adam shot frequently at the indoor range in Bridgeport. 04 stated that after shooting with Adam and Nancy, he had since seen Nancy at "My Place" and he asked her what she did with that .45 caliber handgun that she wanted to sell to him. 04 stated that Nancy told him that she sold that gun and others privately through gunbroker.com and that she did not use a dealer to sell the guns. 04 stated that during their conversations, Nancy had mentioned problems with her ex-husband but didn't mention any specific instances. 04 stated that Nancy had also mentioned that Adam was diagnosed with Asperger's Disease (See attached statement).

This interview was concluded at approximately 1914 hours.
