04 was a friend of Adam Lanza's from 2007 until 2008.

ACTION
TAKEN:

On 12/26/12 at approximately 1512 hours, I met with 04 within the Newtown Police Department. Lt. Sinko provided us with his office to obtain a typed written statement from 04 was present during the interview. 04 provided in a sworn written statement the following: "I knew Adam Lanza from the 2007 to 2008 school year. I first met him in 2007 through the Newtown High School Tech Club. At the time, I was 04 and Adam Lanza was a 04. Tech Club is a school organization where students can get together and share a common interest of technology. Our responsibilities in the club were making films for school events, computer repairs, assisting staff with technical difficulties, etc. The last contact I had with Adam Lanza was in 2008. When I first met Adam Lanza he was initially shy but over time he opened up to me and other members of the club. Overall, I considered Adam Lanza to be normal and thought no different of him from other members. I know that he didn't like to be touched (we used to poke him for laughs) and whenever you shook his hand he would immediately use hand sanitizer. I remember one time members of the Club were having a conversation and Adam Lanza made a joke. We all paused for a moment and then started laughing (As it was a funny joke). Soon afterwards we gave Adam Lanza a group hug and he seemed to let us do it without a problem. I would describe Adam Lanza as being extremely bright. He didn't seem to have an attraction to girls or boys. I know Adam Lanza was bullied by the way he walked by other kids in the school, but I never knew him to be a violent person. He never spoke about hurting anyone or using any type of violence. He never spoke to me about firearms nor did I know him to be into paintball, airsoft, or anything like that. Outside of school, Tech Club members would sometimes host and attend LAN (Local Area Network) parties. These parties would be hosted at someone's house and we would eat and play video games. I did attend a LAN party at Adam Lanza's house once in 2008. We all stayed in the basement area for the party. I did meet Ms. Lanza (Nancy), Adam's mother and she seemed very nice. Adam Lanza never gave us a tour of the house outside the basement, so I never saw the inside of his room nor did I observe any firearms in the house.

Adam Lanza did like to play a video game on-line called Fantasy Star Online [sic] (role playing game). He was also into games like Paper Mario, Luigi's Mansion and Pikmin [sic], which I borrowed from him.

He enjoyed watching animated television (Japanese films) with and without subtitles with us all, which we watched in the tech room (Lockdown & Head end; Rooms dedicated to the Tech Club by the school).

During the time that I knew Adam Lanza, he gave me his Nintendo Game Cube. The Game Cube only has a memory bank for video games. You cannot transfer information into the system.

04 [redacted], took Adam Lanza "under his wing" when he got to Newtown High School. 04 [redacted] asked the Tech Club members to take care of him; such as including him in events, i.e., have conversation, eat with him at lunch, etc., just to make him feel welcome. 04 [redacted] was 04 [redacted] in 04 [redacted] and I believe this is the reason Adam Lanza dropped out of school."
