04 went to school with Adam Lanza from 04 grade through 04.

ACTION  
TAKEN:

On 12/26/12 at approximately 1925 hours, Detective Mugavin and I met with 04 within the Troop A barracks. 04 stated verbally and later in a sworn written statement the following: "I first met Adam Lanza at Sandy Hook School in 04 grade. I would describe Adam as a nice kid, sort of withdrawn and I could tell that he was a little off. Throughout the school year Adam seemed to get along with everyone, he would interact but would never engage classmates in conversation. During this school year, I invited all of my classmates over to my house for my birthday party. The one thing that I thought was odd was Adam's mother, Nancy Lanza, stayed for the entire party. Typically, the parents would drop my classmates off at the house and leave. Nancy stayed and helped with the cutting of the cake, etc. Nancy stayed with Adam throughout the entire party, which caused me and my other classmates to not interact as much with him because it wasn't "cool".

After completion of the 04 grade, Adam and I moved onto to the 04; however we were in different classes. Throughout the school year I did see Adam from time to time but never really interacted with him. When I did see him, it was usually at the playground. A group of my classmates and friends would be playing a game and it seemed as though Adam knew and/or realized that he shouldn't be sitting alone. Adam would move towards where we were playing the game but never participated.

After completion of 04 grade, Adam and I moved onto 04 where we were in the same class. My recollection of Adam throughout this school year was minimal, as I could really only recall him from 04 grade. This is most likely the time that Adam started becoming more withdrawn socially, which is the reason for my lapse of memory.

Throughout my [redacted] 04 [redacted], I remember seeing Adam either one or possibly two years. I checked my yearbooks and found out that he wasn't in the school [redacted] 04 [redacted]. Even if a student does not want to participate in the year book photo, [redacted] 04 [redacted] will still list their names without a picture. I do remember seeing Adam during [redacted] 04 [redacted]. From what I remember Adam was not in any of my classes. When I did see Adam he always seemed to be wearing clothing that was too large and had kind of an unkempt look to him. I found it strange and isolating that Adam would not carry a backpack like the rest of the students, but would carry a briefcase. I do know that Adam participated in the school Tech Club and I believe he participated in the Stage Crew. It seemed as though Adam preferred to be on his own rather than attempting to be social making friends.

Throughout all of the years that I have known/seen Adam, I never remembered him to be a victim of bullying.

I cannot recall the time frame but Adam did participate in Boy Scouts. I know this was during the time that Adam's father (Peter) was still around. During Boy Scouts events, Adam seem to do the bare minimum as far as participation goes. He really didn't take to a special interest and/or hobby. In my opinion it appeared as though Adam was forced to participate in Boy Scouts by his family.
