04

Information was received that 04 was a life long friend of Nancy Lanza, and that Nancy had visited 04 approximately two (2) weeks prior of the school shooting.

ACTION TAKEN:

On 12/15/2012 at approximately 10:45 hours I telephoned and spoke with a woman who identified herself as 04 confirmed that she and Nancy have been life long friends since the 04 further related that Nancy had visited her two weeks ago (12/01/2012). Nancy had stopped by her house on her way back from Bethel, Maine where she was visiting 04. 04 believes that Nancy stayed at the Bethel Hill Bed and Breakfast.

04 was aware that Adam had aspergers, and Nancy talked about how Adam was becoming increasingly despondent. Adam had not left his room in the past three (3) months. Nancy was having to cater to Adam's every need, and although Nancy and Adam resided in the same house, they (Nancy and Adam) only communicated with one another via e-mail. 04 claimed that Nancy attributed all of Adam's behavior to aspergers and

Nancy expressed how sorry she felt for Adam.

Nancy had explained to her that Adam had no emotional connection to her (Nancy). She (Nancy) had asked Adam if he would feel bad if anything happened to her and his reply was no.

Adam disliked Christmas and because of this dislike, Nancy was unable to put up a Christmas tree in their house. The recent storm Hurricane Sandy put Adam over the edge after they had lost power. While the power was out for several days, Nancy tried to convince Adam to leave the house to stay at a hotel or in a recreational vehicle to no avail.

Nancy never expressed any concern about fearing for her safety while alone with Adam, and [04] was unaware of any physical abuse sustained from Adam.

Following my telephone interview with [04], the information gathered from [04] was provided to A.S.A.C. Rhonda Glover of the Federal Bureau of Investigation (F.B.I.) who in turn forwarded it to an F.B.I. field office in Massachusetts for a follow up in person interview with [04] (REFER TO INTERVIEW REPORT SUBMITTED BY F.B.I.)

On 12/21/2012 at approximately 10:00 hours I telephoned and spoke with [04] concerning any knowledge she may have concerning Nancy's use of firearms. [04] explained that she ([04]) was not an advocate of guns but was aware that Nancy was. She and Nancy respected each other's views regarding guns and never talked about guns. Nancy did mention to her that she did keep a handgun in her bedroom night stand, and Nancy's explanation for this was that it made her feel safe [REDACTED] 17, 04, 03 [REDACTED]. [04] again reiterated that Nancy never mentioned anything about feeling threatened by Adam. [04] did recall Nancy talking about how she recently purchased Adam another video game. [04] could not recall the name of the game. Based on prior conversations with Nancy, [04] believed Adam played many violent/ shooting type games. The subject of the types of games she purchased for Adam was another topic they (Nancy and [04]) disagreed on and spoke little about.
