04 videoed the scene of Sandy Hook Elementary School on 12/14/12.

ACTION
TAKEN:

On 12/27/12 at approximately 1430 hours, Det. Jewiss and I met with 04 within the Southbury State Police barracks. 04 voluntarily wanted to provide Detectives with video footage that he obtained utilizing his iPhone at the Sandy Hook Elementary School shooting the morning of 12/14/12. 04 provided verbally and later in a sworn written statement that on 12/14/12 he observed several Troopers responding in the direction of Sandy Hook Elementary School and Newtown High School. [REDACTED] 01 02, 04. He followed the Troopers which led him to the Elementary School, [REDACTED] 01 02, 04. Once he arrived, he learned that there had been a shooting within the school. 04 starting filming the scene utilizing his iPhone to show [REDACTED] 01 02, 04 [REDACTED]

Before 04 met with Detectives 04 copied the videos from his iPhone to a thumb drive. 04 voluntarily provided me with the thumb drive, which I copied onto my assigned computer.

04 went on to state that the main reason he wanted to show Detectives the videos is because a man came out of nowhere, holding a weapon and had no Police markings on. 04 asked the man who he was and the man stated "Major Crimes." 04 described the man as being approximately 6'0" tall, gray hair in his 60's. 04 was concerned that this man could have been another shooter. (See attached written statement, Refer to exhibit report # 339).

After Det. Jewiss and I reviewed the video we confirmed that the man described by 04 is in fact Det. Lukienchuk, who is an active member of the Connecticut State Police Western District Major Crime Squad.
