Action Taken:

On 12/14/12 at approximately 1524 hours James Champion contacted the Newtown Police Department. At which time I was requested by a Sergeant from Newtown Police to speak with Champion. Upon answering the phone, I identified myself as a detective with the Connecticut State Police and Champion identified himself as a sheriff for the Kingstown Police Department in New Hampshire. Champion stated that his sister, Nancy Lanza ((c) [REDACTED] 03, 05), (h) 203-426-8167) lives at 36 Yogananda Street in Sandy Hook CT and has two boys. One son is Ryan Lanza who lives in Hoboken New Jersey and is a CPA in New York City. The second son is Adam Lanza who lives in Sandy Hook CT with his mother. Champion further stated that Adam is antisocial but is very intelligent and has Aspergers which is a form of Autism. Champion last saw the boys and Nancy two years ago. The boys and Nancy would target shoot in New Hampshire. Champion also added that Nancy's ex husband was Peter Lanza but he was unsure of Peter's whereabouts. During our conversation Champion asked if his sister was alive. I informed Champion that I could not provide

that information as this was an active investigation. Champion asked if he should start driving to CT and I suggested he wait to find out more information. Champion then stated that FBI agents just arrived at his residence in New Hampshire.

On 12/14/12 I provided an update to Detective Jewiss #336 regarding the conversation with Champion. Detective Jewiss #336 stated that notification was made by the FBI to Champion regarding the death of his sister, Nancy Lanza.
