Action Taken:

On 12/14/12, [04] provided a written statement summarized as follows:

[04] had conversations in the past with Nancy Lanza while in My Place Restaurant in Newtown. On a number of occasions [04] remembers Nancy stating that she owned a number of firearms. She also stated that she didn't have a permit. Nancy asked what was needed to ship or get rid of them. [04] believes she bought them in New Hampshire because she told [04] she was born and raised there and learned how to shoot there. At one point Nancy spoke of her son Adam. She shared that Adam has Aspergers syndrome. Over the years [04] has seen Nancy, he has never seen Adam. [04] met Ryan her other son. About five years ago, when Ryan was 18 years old, Ryan did some work for [04] at the [04] owned. He did some paperwork for [04] on maybe five or six occasions. Ryan was bright and a great kid. [04] doesn't believe he has seen him since. About thirteen months ago [04] began a new business that Nancy became aware of. Nancy had said outward that [04] business could be a possible job opportunity for her boy. That possibility was never explored. Since that time [04] ran into Nancy three times.

The written statement was signed by [04] witnessed by Detective Flynn #644 and I notarized the statement.
