On 12/17/2012 at approximately 1000 hours I telephoned the aforementioned number and spoke with a woman who identified herself as 04 who resides at 04, 03 related that she is 04 04 of Dr. Paul Fox and further confirmed that Dr. Fox now resides in New Zealand. was hesitant to provide me with Dr. Fox's contact information over the telephone, at which time I provided her with my police credentials and contact information 04 stated that she would contact Dr. Fox and have him contact me per my request. On 12/17/2012 at approximately 1200 hours, I received a telephone call from an individual who identified himself as Dr. Paul Fox. Dr. Fox related that he heard about the school shooting and vaguely recalls treating Adam Lanza. The only records he had with him in New Zealand concerning Adam Lanza were billing records. He explained that all of his medical records pertaining to clients he treated in the United States are currently in storage in the United States. Dr. Fox refused to disclose where his files were stored, however he would call me back after he had an associate examine his files. On 12/18/2012 I received a telephone call back from Dr. Fox. Dr. Fox explained that any medical records pertaining to Adam Lanza have been destroyed since it has been over five (5) years since he last treated him (per state statute he is allowed to destroy any files over 5 years old). Dr. Fox did recall that Adam was about 15 years of age when he last saw him and recalls Adam having aggression problems and possibly having been diagnosed with Asperger's Syndrome. He recalled Adam as very rigid and resistant to engagement. He was unable to provide any further details concerning Adam. Dr. Fox assured me that he would contact me if he locates any medical records pertaining to Adam Lanza. This information was passed on to members of the Federal Bureau of Investigation.
