TELEPHONE INTERVIEW WITH PROFESSOR TERESA STRAMIELLO- WESTERN CONNECTICUT STATE UNIVERSITY

DATE AND TIME OF INTERVIEW: On 01/25/2013 between the hours of 1510 and 1525 .

ACTION TAKEN: On 01/25/13 between the hours of 1510 and 1525, I interviewed Professor Teresa Stramiello from Western Connecticut State University regarding Adam Lanza's status as a possible student of hers. Professor Stramiello stated that she has been a professor of history for approximately 15 years at WCSU. She teaches two courses: American History Since 1877 and American Perspective. Professor Stramiello stated that she researched her data base back to 2005 and she does not have any record of Adam Lanza as a student in her class. Professor Stramiello stated that she keeps very good records consisting of lists of her students and their final grades. She stated that her classes have typically 36-38 students enrolled. Professor Stramiello stated that at the beginning of the semester, students enroll in classes and then students will drop out by a certain "drop date" (those dates will vary with each class) . Professor Stramiello stated that if Adam Lanza was in her class and he dropped out by the drop date, she would not have known this or remembered him.

CASE STATUS: This case will remain open pending further investigation.
