ACTION TAKEN:

On 12/20/12 at approximately 1300 hours, I was assigned to contact the Family Court in Danbury, CT to determine if any documents were filed by Nancy Lanza regarding care/custody of Adam Lanza. At approximately 1305 hours, I spoke to Lou Pace in the Clerk's Office at Superior Court GA #3 located at 146 White St. in Danbury. Pace advised me that any filings related to care/custody or conservatorship would be filed through the Probate Court and not the Superior Court/Family Court. Pace referred me to the Probate Court of Northern Fairfield County-District 45 located in Bethel, CT.

At approximately 1310 hours, I attempted to contact the Probate Court via telephone (203-794-8508) and left a voicemail message for the court to return my call. At approximately 1430 hours, I received a call from Jackie Buckle at the Probate Court. Buckle searched for both Nancy Lanza and Adam Lanza and was unable to locate any petitions under either name.

CASE STATUS:

This case remains ACTIVE pending further investigation.
