ACTION TAKEN:

On 12/19/12 at approximately 1335 hours, I was assigned to follow up on an email from Dave Johnson at the Walt Disney Company Global Security Department. At approximately 1355 hours, I contacted Johnson via phone (818-560-7248). Johnson advised that Walt Disney is affiliated with ABC News. Johnson stated that ABC Nightline had received an email tip about a Facebook post featuring disturbing photos of Columbine shooting suspects Harris and Klebold laying in pools of blood. The person making the post is identified as Anonymous (ID iKTatjYX). The Facebook post stated "im going to kill myself on Friday and it will make the news, be watching at 9am" then someone else identified as Anonymous (ID HgS6JSE8) asks "where at." and Anonymous (ID iKTatjYX) states "i live in Conneticut, that's as much as i'll say". Upon seeing the Facebook posts to include the photos, I realized that the corresponding Facebook page had previously been taken down by the FBI. A copy of the posting is attached to this supplementary report.

CASE STATUS:

This case remains ACTIVE pending further investigation.




