
Action Taken: On 12/20/12, this Detective received a lead sheet from Detective Mudry #824 regarding an organization identified as "WeChare," which was described as being a non-profit group out of Danbury that provides services to children with disabilities. The lead was called in by **04** [REDACTED], who remembered the shooter, Adam Lanza, as being a client. **04** advised that the school that Lanza attended should have maintained a file which would have reflected their agency's involvement and services provided.

On 12/20/12, this Detective conducted an Internet search of the organization and identified WECAHR as being the Western CT Association for Human Rights, located at 268 Main Street, Danbury, CT.

On 12/20/12, this Detective reviewed the school records pertaining to Adam Lanza, which were seized under Federal subpoena, but found no documentation pertaining to WECAHR. The aforementioned documents include, in part, documentation from Lanza's PPTs from the 1st through the 11th grade.

On 12/20/12, this Detective contacted Shirley Ricart, Executive Director of WECAHR, and explained that the State Police had received a tip indicating that WECAHR may have provided services to Lanza, but found no documentation of such in subpoenaed school records. Ricart stated that she would check the records and that if there was any indication that they had serviced the shooter or his family, she would need either a subpoena or a search warrant to release the records. Ricart advised that their agency would be closed until 1/2/13, and that she would contact this Detective on the 2nd with the outcome of her inquiry.

On 1/2/13, this Detective received a voice mail message from Ricart advising that she had searched and inquired regarding the Lanza family, but has found no documentation of any involvement with them or any services provided to them.
