Erik Duff ACTION TAKEN: Interview of Erik L. Duff (D.O.B. [REDACTED] 03 ) on 12/14/12 at 1900 hours

On the above mentioned date and time this Detective and Det. Kimball interviewed Duff at his place of employment, Dick's Sporting Goods in Danbury Connecticut.

At approximately 1900 hours on 12/14/12 Duff began his statement. Duff completed his written statement at 1946 hours on 12/14/12. Duff swore to and signed his statement. (See attached written statement) Among other things, Duff provided the following information in his statement:

On Tuesday 12/11/12 Duff was working his regular shift at Dick's Sporting Goods in Danbury Connecticut from 3:00 pm to 11:00 pm. Duff remembered that at some point during his shift, he interacted with two groups of individuals. Duff was interviewed based on information that the suspect Adam Lanza may have been in one of these groups attempting to purchase a weapon. The group in question was a group of four white males, who all appeared to be in their twenties.

Duff was shown two photographs, one of Ryan Lanza, and one of Adam Lanza. The photographs did not contain any identifying information. Duff remarked that one photograph looked familiar, and this photograph was of Adam Lanza. Duff also indicated that within this group of males, only one was actually speaking to him, and it was not the two persons depicted in

the photographs he was shown.

Duff could not remember any of the conversation with this group, only that the one male doing all the talking was interested in a crossbow, but it was not for sale because it was a display model.

Duff stated that he was positive that no one in the group requested paperwork to fill out in order to purchase a firearm. Duff was also positive that they never indicated that they were interested in purchasing a firearm.

In addition to the information contained in the statement, Duff also provided the following information verbally:

Duff stated that on occasion they do have customers that want to purchase weapons based on theories that the world is coming to an end or similar scenarios. Duff said that this was not the case with this group, and they did not make mention of anything alarming or out of the ordinary. Duff again reiterated that the one unidentified male was only interested and talking about purchasing the crossbow. Duff said his interaction with this group was "normal" and did not seem odd in any way.
