

She stated that she observed a vehicle parked in the lot with the operator outside of the vehicle and reaching into the back seat of the vehicle.

On 01/04/13 at approximately 1100 hours, I received a phone call from 01 02, 03, 04 She stated that on 12/13/12, she was in the parking lot at CVS Pharmacy on Queen St. in Newtown. She stated that she observed a vehicle parked in the lot with the operator outside of the vehicle and reaching into the back seat of the vehicle and perhaps needed some help with the installation.

On 01/04/13 at approximately 1100 hours, I received a phone call from 01 02, 03, 04 She stated that on 12/13/12, she was in the parking lot at CVS Pharmacy on Queen St. in Newtown. She stated that it appeared as if the operator outside of the vehicle and reaching into the back seat of the vehicle and began to approach the vehicle when she realized that the person was not trying to install a car seat but was just fumbling with items in the back seat.
