**PHONE INTERVIEW REPORT**

DATE AND TIME: On 01/04/12 from approximately 1100 hours to approximately 1110 hours.

**ACTION TAKEN:**

On 01/03/13 at approximately 1500 hours, I was assigned by Sgt. Pattberg to contact Lt. Keith White from Monroe Police Department regarding a concerned parent from Sandy Hook. At approximately 1527 hours, I spoke to Lt. White via telephone. White advised that 01 02, 03, 04 is a concerned parent of a Sandy Hook Elementary School student. White stated that 01 02, 03, 04 believes that she may have seen Adam Lanza in the parking lot of CVS in Newtown on the night prior to the shooting at the school.

At approximately 1552 hours, I attempted to contact 01 02, 03, 04 at the phone number provided by White. I left a voicemail message for 01 02, 03, 04 to return my call.

On 01/04/13 at approximately 1100 hours, I received a phone call from [01 02, 03, 04] She stated that on 12/13/12, she was in the parking lot at CVS Pharmacy on Queen St. in Newtown. She stated that she observed a vehicle parked in the lot with the operator outside of the vehicle and reaching into the back seat of the vehicle. [01 02, 03, 04] stated that it appeared as if the operator was attempting to install a child's car seat in the back seat of the vehicle and perhaps needed some help with the installation. [01 02, 03, 04] stated that she exited her vehicle and began to approach the vehicle when she realized that the person was not trying to install a car seat but was just fumbling with items in the back seat. [01 02, 03, 04] stated that once she realized what the person was doing, she returned to her vehicle and departed the CVS parking lot. [01 02, 03, 04] described the vehicle as an older model dark-colored car. She stated that the back seat was full of items but she could not identify the items. [01 02, 03, 04] stated that she identified the vehicle as an older model car due to the fact that it was dirty and rusted. She further stated that it appeared as if the person may have been living out of the vehicle. I advised [01 02, 03, 04] that the description that she provided for the vehicle did not match the vehicle driven by Lanza since his vehicle was a newer model with no rust and it appeared clean and tidy. [01 02, 03, 04] indicated that she felt relieved and did not have any additional information to provide. There was no need to obtain a written statement from [01 02, 03, 04] This phone interview was concluded at approximately 1110 hours.

CASE STATUS:

This case remains ACTIVE pending further investigation.
