ACTION TAKEN:

On 01/07/13 at approximately 1130 hours, I was assigned by Sgt. Pattberg to contact Mary Pat Healy at the Bridgeport Child Advocacy Center. Healy had received an unsolicited email from an unknown sender which references the Newtown School Shooting for the basis of a public motion. The subject line of the email is titled Newtown Toronto Motion 4 Safety. The email makes mention of corruption within the Newtown Police force and calls for the removal of the corrupt officers from the investigation and replacement with new officers.

At approximately 1230 hours, I researched the "Newtown Toronto Motion 4 Safety" through the internet. A search of that topic brought me to a site called Status Bin. This is a site for informational sharing through social media sites such as Facebook and Twitter. On Status Bin, a 2-part article was posted through Facebook by a user identified as Anna Goralczyk. The article claims that there is corruption among the political leaders and law enforcement officials of Canada and the United States. The article indicates that crimes are going without proper investigation in an effort to hide the corruption. The article claims that law enforcement officers are claiming Post Traumatic Stress Disorder to avoid properly investigating the Newtown School Shooting and it is the writer's belief that the law enforcement officers are trying to avoid the investigation to cover up the involvement of government officials in the shooting. The article does not seem threatening in nature and contains no information relevant to the Newtown School Shooting Investigation.

On 01/08/13 at approximately 1245 hours, I spoke to Mary Pat Healy via telephone. Healy confirmed that the email was received without solicitation and that the sender was not familiar to her. Healy had no further information to provide.
