#### ACTION TAKEN:

On 12/28/12 at approximately 1405 hours, Det. Van Ness and I met with **O4** within his residence. **O4** stated verbally and later in a sworn written statement that approximately two (2) days after the school shooting he was playing Battlefield 3 on-line with his X-Box. He was searching the Browser to find a group to play with and clicked on "Snow and Sorrow". **O4** viewed this persons profile and the title was called Sandy Hook Shooting Range. This person also posted a "creepy" poem and stated "spill their guts". At the time, **O4** we was that twenty-one (21) people were playing in that particular group. **O4** reported the incident to the Police and called EA, the game maker. EA stated that they would remove Snow and Sorrow's browser.

took photographs from his television with his iPhone of the browser information and voluntarily e-mailed the pictures to my State Police account. (See attached written statement and photographs for details.)


