04 viewed a disturbing X-Box game post pertaining to the Sandy Hook School shooting.

ACTION
TAKEN:

On 12/28/12 at approximately 1405 hours, Det. Van Ness and I met with 04 within his residence. 04 stated verbally and later in a sworn written statement that approximately two (2) days after the school shooting he was playing Battlefield 3 on-line with his X-Box. He was searching the Browser to find a group to play with and clicked on "Snow and Sorrow". 04 viewed this persons profile and the title was called Sandy Hook Shooting Range. This person also posted a "creepy" poem and stated "spill their guts". At the time, 04 saw that twenty-one (21) people were playing in that particular group. 04 reported the incident to the Police and called EA, the game maker. EA stated that they would remove Snow and Sorrow's browser.

04 took photographs from his television with his iPhone of the browser information and voluntarily e-mailed the pictures to my State Police account. (See attached written statement and photographs for details.)

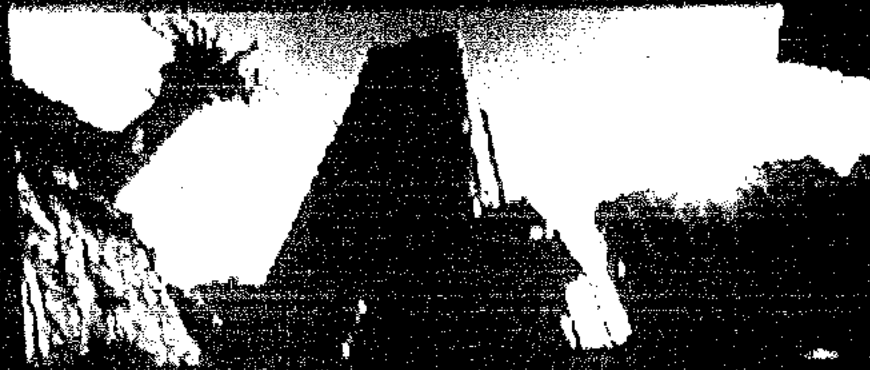

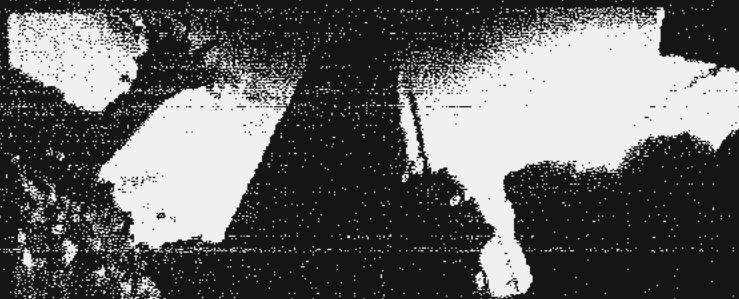

I stopped in my office this afternoon and had reviewed a phone message on my office line from a guy named [REDACTED] 04 who stated that he was gaming, X-Box on-line, on Monday 10/17 and discovered a disturbing site/gammer named "**sandy hook shoofting range**"., he went on to say that he probed the information/site further and was disturbed by what he observed on the gamers server site. He further stated that he wanted to forward this information to the "right people."

His last name was not audible on the voice mail aside from it started with a "S" but his contact numbers were as follows;
