ACTION TAKEN:

Sgt. Davison received a voice message from [REDACTED] 04, 03 who claims he has information on the Sandy Hook shooting.

On January 14th, 2013, at approximately 1556 hours, I spoke with [REDACTED] 04 by phone. [REDACTED] 04 stated that he strongly believes (80% certainty) that [REDACTED] 17 was actually behind the shootings. [REDACTED] 04 feels that [REDACTED] 17 influenced and/or hypnotized Adam Lanza through the internet to commit these crimes, which is the reason why Adam "smashed" his computer. [REDACTED] 04 feels the reason behind the crimes is because Nancy Lanza was going to get a judgment on [REDACTED] 17.
