
On 01/17/13 at 1400 hours, 04 of came to Troop A to provide a statement. 04 was escorted to the roll call room on the lower level for
the interview. Detective Peters joined me on the interview. 104 to provided a verbal account to Detective Peters and myself. I then reduced he
statement to a typed statement form. The following is the written statement provided by 04
"I am a landlord who rents property in 04 11. On 04 /12, I placed an ad on Craigslist to rent a room in my house at 04, 03
. The ad ran on Craigslist until 04 /12. Sometime between those dates, I believe that I received a phone call from a male who identified
himself as "Adam". He requested to rent a room at my house. When I asked him for his last name, he was reluctant to give me any additional
information. Adam asked me if he could see the room. I asked Adam questions about his job and finances to determine if he was qualified to rent
the room. I was asking for \$140/week for the room and require tenants to have income of at least \$500-600/week in order to qualify. Adam
indicated that he is a part-time "helper" in the school system. When I asked him how much money he makes per hour, Adam did not want to
disclose that information. Based on my previous experience as a paralegal in the school system, I know that the school used to only pay
approximately \$9.00/hour. I also know that the school used to only authorize part-time workers to work 27 hours per week. Based on the rate and

begged me to see the room but I told him that I could not rent to him. I offered options to Adam in an effort to help him but he was not accepting. Adam indicated that his mother is driving him crazy and that if he doesn't move out of her house, he might "do something crazy". I asked him what he meant. I asked if he meant that he would hurt himself or damage someone's property. Adam stated that he might do something worse. I asked what could be worse and Adam would not tell me. I asked Adam if his mother would be willing to help. Adam indicated that the reason that he wanted to leave his house is that his mother is "cruel to him". I asked Adam what his mother did that was cruel. I asked if she abused him or something. Adam would not disclose what she did that was cruel but gave one example as she owned a lot of guns. I told Adam that many people own guns and that I didn't deem that as cruel. I tried to suggest that he talk to friends or family to try to work things out with his mother until he could find a different job and eventually be able to move out of his mother's house. I told him to call me if he needed to talk or if his situation changed. He

hours worked, I determined that Adam would not financially qualify to rent from me. I told Adam that I would not be able to rent to him. Adam

About 20 minutes later, I called the Newtown Police and explained my conversation with Adam. I gave them the phone number that Adam called me from. The person that I talked to asked if Adam was harassing me. When I told them that he was not harassing, the person that I spoke to indicated that they would definitely call the number to check on him but they were not really able to do anything because he had not committed a crime. They stated that if he had said that he is "definitely" going to do something, then maybe they could act on it but since he stated that he "might"

do something, the most they could do was go to his house to check on his well being and talk to the people in his house. I believe that police officers should be able to follow up on calls about people who seem to be in distress or angered, without having to put them in jail. I believe that police officers should be able to call in experts who could get these people help right away." (see attached statement)

**NoteDuring our interview, 04 kept referring to a notebook for information. A review of the notebook showed, what appeared to be,
disorganized and irrelevant notes and doodles. 04 also relayed a story about a young lady who had called to rent one of her other properties
in 04 indicated that she was unable to rent the property to her and also that the lady ended up getting killed. 04 stated
that she felt bad that she denied these two individuals from renting her properties and then horrible things happened to them.
On 01/18/13 at approximately 0800 hours, I contacted Newtown Police Dept. to attempt to identify the date and time that 04 11 reported the
phone conversation to them. I was also trying to identify the phone number that "Adam" called 04 of from so that I can confirm that the call was
indeed Adam Lanza. A check of the Newtown Police Department dispatch records show no contact with 04 and during the time period in which
she claims to have made the call. The dispatcher indicated that the last contact with 404 was on 01/22/12, when she called to request
assistance in the eviction of her previous tenant, who was had identified in our interview as well as 04
On 01/18/13 at approximately 1100 hours, I left a voicemail message for 04 to confirm the call to Newtown Police Dept. as well as to confirm
the approximate dates of the call. At approximately 1115 hours, 04 returned my call. She confirmed that the date of her call to Newtown
Police was between 02/20/12 and 04/06/12. Based on the lack of records of the phone call from "Adam" or to the Newtown Police Dept., I am
unable to confirm the source of the phone call from "Adam". When I asked her if she wrote down the phone number which "Adam" called from, she
indicated that she did, but was unable to locate the notebook in which she wrote it. I requested that 04 obtain a copy of her call records
from her cell phone company that I could compare to Adam Lanza's phone number to determine the validity of her statement. 04 indicated
that she would make to request to Verizon and email the records to me.
