**ACTION TAKEN:**

On 01/18/13 at approximately 1345 hours, I received an email from [04] with her cell phone call records attached. I reviewed all calls from her cell phone in the time period of Feb.20--Apr. 6, 2012. The only call to Newtown Police Dept. during that time frame is on March 6th at 1629 hours and the call lasted for 4 minutes.

On 01/21/13 at approximately 0800 hours, I contacted Newtown Police Dept. to have the phone recordings reviewed. I spoke to Dispatcher Newton who indicated that the phone recordings are saved for at least two years. Dispatcher Newton transferred my call to Sgt. Santucci. Santucci reviewed the call from [04] made on March 6th. In the recording, [04] is reporting an annoying phone call from a man she identifies as "[04]". [04] indicates that the call is made from a "restricted number." [04] is inquiring about how to handle harassing calls. [04] was advised by the dispatcher to ask him not to call again and then if he continues to call, she should call the police. In the recording of the call, there is no indication from [04] that the caller made any threat that he "might" do something bad. [04] makes no mention of the caller being "Adam" or that the call was about renting her property.

I checked [04] phone records from December 16, 2011 through May 15, 2012 for phone calls from any phones related to Nancy, Adam or Ryan Lanza to include the following phone numbers:
