

himself at 9am on Friday and telling everyone to watch the news. The posts mentioned by 04 were previously investigated and deemed to be fake by agents from the FBI (see attached web posts).

of further stated that "throwitup" had a youtube channel called Spin Cycle Submission. A review of the channel revealed a white male subject giving his personal opinion on various topics related to violence by young males, to include circumcision, which he refers to as genital mutilation.

Based on the investigation into the screen name by the FBI which 04 identified as ixty???, there is no evidence that shows that 04 indeed have contact with Adam Lanza.

CASE STATUS:

This case remains ACTIVE pending further investigation.
