On 01/28/13, I followed up with Dilorenzo via telephone. She indicated that she had not been able to reach the ^{04, 01 02} family but she would put my call on hold while she tried again. Dilorenzo then returned to the line and indicated that she had reached ^{04, 01 02}. Dilorenzo provided me with the name and number for ^{04, 01 02}. At approximately 1340 hours, I spoke to ^{04, 01 02} via telephone. ^{04, 01 02} stated that she never went to Sandy Hook Elementary on 12/14/12. She stated that she had an appointment for a PPT meeting at 1100 hours. She stated that she was at Panera Bread at around 1015 hours when she received an alert on her cell phone about the shooting at Sandy Hook Elementary.

Based on my brief phone interview, it is not necessary to obtain a written statement from 04,0102 as she was not at the school at the time of the shooting.
