DATE AND TIME: On January 28, 2013 from approximately 1340 to 1350 hours.

**ACTION TAKEN:**

On 01/16/13, I was assigned to identify and contact a parent who may have been in the parking lot of Sandy Hook Elementary on 12/14/12. It was learned through the investigation that there was a second PPT meeting scheduled to follow the PPT meeting that was occurring at the time of the shooting. On 01/16/13 at approximately 1515 hours, I left a message for school staff at Sandy Hook Elementary School to contact me in an effort to identify the parents scheduled for the second meeting. On 01/17/13, I contacted the school a second time and I was advised to call back on 01/22/13 when [REDACTED] 04 was working.

On 01/22/13 at approximately 0925 hours, I spoke to [REDACTED] 04. She advised that the second meeting was scheduled for 1100 hours on 12/14/12. She could only identify the family by last name [REDACTED] 04, 01 02. She stated that the family was looking to enroll their child in the pre-school

program and since they were not current students, she did not have any additional information. [04] directed my call to Bonnie Dilorenzo in the Pupil Services Office at the Board of Education. [04] advised that she could not provide me with any information on the [04, 01 02] family but she would contact them and have them call me.

On 01/28/13, I followed up with Dilorenzo via telephone. She indicated that she had not been able to reach the [04, 01 02] family but she would put my call on hold while she tried again. Dilorenzo then returned to the line and indicated that she had reached [04, 01 02]. Dilorenzo provided me with the name and number for [04, 01 02]. At approximately 1340 hours, I spoke to [04, 01 02] via telephone. [04, 01 02] stated that she never went to Sandy Hook Elementary on 12/14/12. She stated that she had an appointment for a PPT meeting at 1100 hours. She stated that she was at Panera Bread at around 1015 hours when she received an alert on her cell phone about the shooting at Sandy Hook Elementary.

Based on my brief phone interview, it is not necessary to obtain a written statement from [04, 01 02] as she was not at the school at the time of the shooting.

CASE STATUS:

This case remains ACTIVE pending further investigation.
