Kohlhase began researching the hum in 2009 after renovations were made to the natural gas lines in the area of his home in Brookfield. Kohlhase began hearing the hum at his home and began researching in areas that may be affected due to location to the gas lines. It is Kohlhase's belief that Adam Lanza may have been affected by the hum and that the hum may have been a contributor to Adam Lanza's mental state (See attached informational binder).
