DATE AND TIME: On February 19, 2013 from approximately 1530 hours to approximately 1550 hours.

ACTION TAKEN:

On 02/19/13 at approximately 1500 hours, I was assigned to contact and interview Judith Angeline regarding the Sandy Hook Elementary School Shooting and her knowledge of Adam Lanza (see attached email). At approximately 1530 hours, I contacted Angeline via her cell phone at 03 [REDACTED]

Angeline stated that she knew the Lanza family when they lived in South Brunswick, NJ in the mid 1990's. She stated that at that time, Adam and his brother, who she identified as "Peter", were constantly in trouble. She stated that Adam's brother, Peter, was hit by a car and killed when they lived in Newtown so she doesn't know much about him. She stated that their problems all began when Adam was a teenager in 1994. She stated that Adam and Peter wrote children's books and then the books were published under another author due to Adam and Peter being underage. She

stated that Adam and Peter felt slighted by not receiving the profits. She stated that Adam and Peter's father, who she identified as Adam Sr., believed that the children should "earn their keep" and therefore forced them to go to work at an early age. She stated the Adam and Peter didn't want to work so they got multiple credit cards in their names and charged all of their purchases. She stated that failure to pay the credit card companies led to Adam being arrested in Manhattan in the late 1990's and that is where she met Adam. She stated that she was at the courthouse when Adam came in for a court date for larceny. She stated that she talked to him and he told her his life story to include the facts about the children's books and the death of his brother, Peter.

Based on our conversation, Angeline identifies Adam as a teenager in the 1990's and in fact he was not born until 1992. She also stated that his brother's name was Peter and he was killed when he was hit by a car. All of the facts relayed by Angeline appear to be inaccurate and the bits of information that she did provide seemed to be obtained from the media to include the name Peter, which was his father and not his brother.

Due to the inaccuracy of Angeline's statement, it appears that she had no information to add to this investigation.

CASE STATUS:

This case remains ACTIVE pending further investigation.
