Action Taken: On 1/9/13, Detective Jewiss #336 received a request for investigative assistance from Detective Mike Goss of the Lake County, Florida, Sheriff's Office Intel Unit, regarding a possible suspect in a threatening/suspicious incident case involving a retired Sandy Hook Elementary School teacher. The suspect in the incident was identified as possibly being [REDACTED] 17 and was described as a white male who would have been a student at S.H.E.S. in the mid-1980's, possibly between 1984 and 1986.

A separate case number was generated for the investigation into [REDACTED] 17 under companion case CFS-13-00020848. The investigation into [REDACTED] 17 was coded as an assist to Florida and was closed following the relay of the necessary investigative information.

The status of this case remains actively under investigation.
