DATE AND TIME: March 5, 2013 from approximately 1200 hours to approximately 1210 hours.

ACTION TAKEN:

On 03/05/13 at approximately 1000 hours, I was assigned to contact Kim Lacapria regarding information that she may have about the Sandy Hook Elementary School Shooting. At approximately 1200 hours, I contacted Lacapria via cell phone. Lacapria stated that she is a reporter in Suffolk County, New York. She stated that she had recently written a news article about Gene Rosen and the harassment that he was getting from conspiracy theorists. Gene Rosen was a gentleman who lived in close proximity to the school and had located several children on his front lawn following the shooting.

Lacapria stated that since writing the article, she found a Youtube posting in which all her personal information to include her address, phone

number and parents names/address/phone number were posted for all users to see. She stated that the posting has since been removed but other postings about the shooting have been posted by the same user account. Lacapria advised that I search "scotty walker youtube" through Google search and review his postings. She specifically noted a posting about the Chief Medical Examiner Dr. Wayne Carver. When I searched the user that she indicated, I found the following post regarding Dr. Carver

The post seems to be a recording between a man who calls in about the **01 02 03 12** autopsy, and the secretary in the Office of the Chief Medical Examiner. The caller is questioning the results of the autopsy and the policy of releasing information to the media.

Based on the information gathered, there is no further investigation needed. There does not appear to be a violation of any sort and no link to the shooting at Sandy Hook Elementary School.

CASE STATUS:

This case remains ACTIVE pending further investigation.
