ACTION TAKEN:

On 03/27/13, I was assigned to review a package of information received at the State Police Headquarters at 1111 Country Club Rd. in Middletown. The package was labeled with a sender name of Johnny Devincenzo and a return address of [REDACTED] 04, 03. The contents of the package included a hand-written note signed by Johnny Devincenzo as well as a 5-page typed document titled "The Psychological Profile of the Killer Shooter Lanza".

The hand-written note stated in part as follows:

Sir,
Please accept this psychological profile of the killer, shooter Lanza, as my own creative development and opinion, to help solve the problem of Adman Lanza's final pursuit to kill people. Thanking you for what you may feel is my conclusive opinion. Very truly yours, Johnny Devincenzo (see attached note)

A summary of the 5-page typed document is as follows:

Devincenzo claims that Lanza's abnormal thinking began when [REDACTED] 17 [REDACTED]

Devincenzo mentions the theory that Lanza went to the school for "target practice" but indicated that Lanza took his real intentions to the grave with him.

Devincenzo goes on to claim that Lanza's [REDACTED] 17 [REDACTED]

[REDACTED] Devincenzo claims that Lanza's mother told her son that God gave him a small penis and that Lanza's mother told him that he resembles a little girl with a small penis. He claims that Lanza became so mentally confused as to whether he was a man or a woman. Devincenzo claims that, on the morning of the shooting, Adam Lanza stripped naked and blamed his mother for his small penis and then shot her three times in the face with a hand pistol. He claims that he then went to the school and shot the children so that they would not grow up as he did, to suffer with a small penis, and then he killed the teachers so that they would not teach the children about penis and testical development.

Devincenzo went on to claim that Lanza committed suicide because he believed himself to be "the victim of his own death." He concludes his document with his thoughts on how the confrontation occurred between Lanza and his mother prior to him shooting her three times in the face. (see attached document)

Based on our findings at this point in our investigation, Devincenzo's theories and conclusions are unsubstantiated and irrelevant to this case.

The Psychological Profile of the Killer Shooter Lanza

At this time I am to elaborate to the best of my knowledge concerning the shooter Lanza.

I am positive in belief to know what had transpired psychologically within Lanza's brain, was his truth as he begun shooting his victims to death. No I am not a mind reader, but do know from the news media, that he did kill his mother first.

The abnormal thinking within Lanza's brain begun to unfold at a very young age of about 3 years old. At this age he begins to suffer mentally and physically 17

And when they returned to each other by the living room sofa Lanza stood naked standing before her. Lanza now rejects

mothers birth to him telling her that she was the cause of his small penis and again tells her that he no longer loves her anymore.

The desire again to kill mother seems to become paramount as a result of mother continued nagging him [REDACTED] 17 [REDACTED]

I am at the importance of my acknowledgments to begin into Lanza's reasons that I may have stated before in my writings previously as to why he had killed mother first, school children, and then school teachers together with the children.

It is important to mention that after he killed mother and drove to school that he immediately accepted his idea to kill school children and school teachers. Such of an idea as this had really no meaning for him to ponder upon. When he entered the school and looking at the school children and teachers is when Lanza's sick brain decided to kill them for no other reason other than because they were moving and walking about, to and fro, back and forth.

Lanza's believed now that after shooting mother to death that he had to destroy the teachers as well as the students, so that the children as he believed, would never grow up as he, to suffer with a small penis, and that the teachers would never again teach the small children about penis, testicular development, to be normal in all respects, without physical examination.

Further, Lanza suffered mentally with his problematic description of sexual abnormality about himself. He was no longer in contact with reality. Every child that Lanza had shot while looking at them became his own fixated self. The child or children he was shooting at was himself dying over and over again.

Lanza had finally committed suicide that he believed was himself "the victim of his own death". During the instant time when he began killing the adult teachers, was when he believed. That each teacher had become his mother that he had believed he was killing over and over again.

Lanza, had finally committed suicide that he believed to be himself, "the victim of his own death". The fact of the matter must allow us to realize that Lanza's overall mental illness had caused his thoughts to erupt with such high velocity of electrical current that had stimulated the neurons and cells alike within his brain to fire themselves repeatedly and quickly and indiscriminately all through his internal body.

Allow me now to take the reader back in time to venture with the killer Lanza confronting his mother, with the loaded pistol in his hand and she begged him not to kill her; "Please my son don't kill me." [REDACTED] 17 [REDACTED]

[REDACTED] Now I'm going to kill you." Mother still begging him not to kill her,

meant nothing to his psychotic minds, as he shoots her three times in her face with a loaded pistol.

Hate had departed mother and son from each other so much so, that both of them developed sarcastic attitude that became the final climax to a sorrowful ending of life to both of them.

They both had desired in their own psychological way to commit suicide together. Both of them turned happiness into sadness that had waited for the right time to destroy themselves.
