the Newtown Police Department and inquire about the incident.

On 3/28/13, this Detective spoke with Officer Silver of the Newtown Police Department regarding the incident. Officer Silver stated that he had checked the database and saw that there had been a report made by a resident living at #37 Yogananda pertaining to shots fired in the area. Officer Silver stated that the report had been made approximately a week and a half after the incident, and that the person reporting it had felt it might be pertinent due to the fact that several similar incidences had occurred in town since. Officer Silver advised that the report stated that there were shots fired in the area of #36 Yogananda in the early morning hours on March 12th. Officer Silver stated that the resident stated specifically that at approximately 1:30 a.m., they had heard a car pull up on the road and fire shots in the direction of #36 Yogananda Street. The resident stated that there had then been two additional shots fired in the #36 direction as it had again passed #36 again. Officer Silver stated that upon receiving the report, Officers had been dispatched to investigate, but had found no evidence of the incident at that time. Officer Silver stated that in response, the Newtown Police Department had increased patrols in the area of Yogananda as a deterrent.
