DATE AND TIME: April 9, 2013 from approximately 1100 hours to 1110 hours.

ACTION TAKEN:

On 04/02/13, I received an email from Special Agent Michael Zuk from the Federal Bureau of Investigation regarding a phone call from Robert Miller. Zuk indicated that he received a phone call from Robert Miller (d.o.b [REDACTED] 03) indicating that [REDACTED] 04 , ran a daycare in the early 1990's called [REDACTED] 04 . Miller stated that he remembers a pretty woman named Nancy with two young boys coming to the daycare around 1993 or 1994. Miller stated that he was not sure that it was the Lanzas but remembered seeing the father at GE in Fairfield. Miller indicated that [REDACTED] 04 physically abused the children in the daycare to include the youngest of Nancy's boys.

On 04/09/13, I spoke to Miller via telephone. Miller told me the same story that he had told Agent Zuk. Miller again could not identify the family as the Lanzas and only knew the mother to be named Nancy with two young sons.

On 04/19/13, Detective Kiely spoke to Peter Lanza regarding the children going to [REDACTED] 04 in 1993 or 1994. Peter Lanza indicated that his family lived in Kingston, New Hampshire and didn't move to Newtown, Connecticut until 1998. Lanza stated that by then, Adam was in first grade and there was no need for him to go to a daycare facility [REDACTED] 04

Based on the above mentioned information, I have determined that the woman named Nancy and the two young boys were not the Lanza family and no follow up investigation is needed with Miller.
