



believes that she observed Adam Lanza at Sandy Hook School during the evening of December 12th, 2012.

ACTION TAKEN:

04 within Chalk Hill School for an interview. 04 stated verbally and later in a sworn written statement Detective Peters and I met with that on Wednesday, December 12th, 2012 at approximately 5 pm in the evening she was at Sandy Hook School for an event. 04 encountered a young adult male in the entryway to the school. The male was wearing a light yellow button down shirt tucked into his pants. He had brownish hair, kind of blunt cut bangs and appeared "awkward." 104 recalls the male bumping into her infant carrier that she was carrying and not holding the door open for her, which she felt was rude. He did not make eye contact with 04 during this encounter. When the male entered the school she believes he went down the right side hallway. 04 remembers a custodian (possibly 04 - later identified as 04 cleaning the left side hallway when the male entered the school. 04 felt that the male was out of place meaning, he was too old to be a student, too young to be a parent and didn't appear to have anyone with him. 04 mentioned this information to a friend (identified as because it made her nervous that anybody could enter the building in the evening.

When the shooting took place on December 14th, 004 immediately thought of the male. When photographs were published by the media of the Sandy Hook School shooter, Adam Lanza, she is 80% sure that the male that bumped into her on the 12th was Adam Lanza (See attached written statement for details).

04 inquired if their was a yellow button down shirt found within the On April 9th, 2012, Det. R. Van Ness received an e-mail from shooter's home, that appeard to have been worn days prior to the incident.

On April 11th, 2012, Det. R. Van Ness contacted the Eastern District Major Crime Squad. The Detective stated that he was pretty confident that their was no yellow shirt, as the shooter's wardrobe consisted of blue shirts and tan pants.
