On December 12th, 2012, at approximately 5 pm a parent observed whom she believed to be Adam Lanza walking through Sandy Hook School. The witness also stated that [Redacted] 04 was in the hallway when the individual believed to be Lanza, walked through the building.

ACTION
TAKEN:

Detective R. Van Ness and I met with [Redacted] 04 within Chalk Hill School. [Redacted] 04 stated verbally and later in a typed sworn written statement the following: "On April 30th, 2013, I voluntarily met with State Police Detectives Mudry and Van Ness within Chaik Hill School.

On December 12th, 2012, I was working [Redacted] 04 at Sandy Hook School. Normally, at 5pm, I would have been working inside my classrooms, not working in a main hallway; however, I can't remember that far back. I don't recall an individual with brownish hair, blunt cut bangs and a yellow tucked in shirt walking through the school. At this time, the building is open for after school programs, so it is possible that this individual could have been in the school without me noticing.

To the best of my recollection, I have never seen the shooter inside Sandy Hook School." (See attached written statement.)

[Redacted] 04 verbally added that he is [Redacted] 04 at Sandy Hook School.
