ACTION TAKEN:

On April 26th, 2013, I received an e-mail from the second second


During the course of a recent interview with **04 101**, participant in a Sandy Hook School event, she disclosed that a younger white male, brownish hair with blunt cut bangs, wearing a yellow tucked in shirt, entered Sandy Hook School at approximately 5 pm on December 12th, 2012. **04** stated that she is 80% certain the male she observed walking into the school was Adam Lanza. Furthermore, she remembered **04 101** (later identified as **100 04 101**) being present at this time (Refer to **104 104 104** statement).

Based on the attendance sheets obtained and the cooperation of **1004**, I will be interviewing the staff of the After School Age Program for the day of December 12th, 2012.

On May 6th, 2013, at approximately 1400 hours, I met with 04 within Chalk Hill School. Most of the employee's that worked on December 12th, 2012 were scheduled to work on this day. In a series of interviews, Det. R. Van Ness and I met separately with each employee in the rainbow room. In summary, the following verbal statements were made:

04.03) stated that at 5 pm there is a lot of activities going on in the school, i.e., basketball, wrestling, etc. Due to all the activities and parent pick up the front door to the school and cafeteria door remain open, so pretty much anyone can get into the school. stated that occasionally an older sibling (18 and older) will pick up their brother or sister, but she does not remember seeing a young male wearing a yellow shirt, tucked into his pants. 04 has seen pictures of the shooter on television and she has never seen him within Sandy Hook School.

2.) 04.03) stated that during the time of 5 pm the school has a lot of activities going on, such as basketball and wrestling. She further stated that the front door and cafeteria door remain unlocked. 04 does not remember seeing a young male wearing a yellow shirt tucked into his pants walking around the school days before the shooting. She has also seen pictures of the shooter on the news and she has never seen him inside the school before.

3.) 04.03 stated that during the time of 5pm the school has a lot of activities going on, including basketball and wrestling. The front door of the school and the cafeteria door remain unlocked at this time. She has no memory of a young male wearing a yellow shirt walking around the school days prior to the shooting. She has seen pictures of the shooter on the news and she has never seen him in the school before.

4.) 04 03 stated that around the time of 5 pm there is a lot of events going on within the school. At this time, the front door and cafeteria doors are unlocked. He has no memory of a young man wearing a yellow shirt walking around the school days before the 04 stated that he routinely removes people from the school if they have no reason to be there or if they are causing problems. He shooting. has seen pictures of the shooter on the news and he has never seen him in the school before.

stated that around the time of 5 pm, the school has a lot of events going on. Because of this, the front door and the 5.) 04,03 cafeteria doors are unlocked. She has never seen a young man wearing a yellow shirt acting odd, within the school. time she saw this male at the school. Additionally, **04** has seen pictures of the shooter through the media and this man was not him. Furthermore, the doors to the school around 5 pm are open.

8.) In an attempt to contact by phone, I spoke with 04 stated that he would rather handle the 04 04 interview himself because 04 04 regarding the man wearing a yellow shirt on December He spoke with stated that she did not see anything out of the ordinary. She never saw a man wearing a yellow shirt at the 12th. 04 speaking for 04 school on December 12th. During the after care program, the school's front door and cafeteria door are unlocked. Furthermore, she has seen pictures of the shooter through the media and she has never seen him at the school. 04 did not want to provide 04 date of birth for confidentiality reasons.

Based on all interviews obtained, I have been unable to corroborate 04 statement that Adam Lanza was at Sandy Hook School on December 12th, 2012.


