On Saturday, December 15, 2012, at approximately 1403 hours, a call was received at the Newtown Emergency Operations Center (EOC) from a man named [Redacted] 04. The call was answered by Fairfield Police Officer Kevin McPadden of the Connecticut Intelligence Center (CTIC). 04 told Officer McPadden that this morning, he was speaking to a man he knows named [Redacted] 04 said that 04 told him he was [Redacted] 04 at the Sandy Hook Elementary School and that he had specific information and details about the shooting at the school.

On Tuesday, December 18, 2012, at approximately 1700 hours, I spoke to [04] via telephone. [04] did not believe that I was a law enforcement officer and was unwilling to share much information. [04] told me that he used to be [04] at the Sandy Hook Elementary School [04] Vest said that he currently lives [04] but would be returning to Connecticut [04] I asked [04] to contact me when he arrived in Connecticut so that he could confirm my identity and we could find out if any of the information he had was pertinent to the investigation. [04] advised me that he would call me upon his arrival in Connecticut.

After speaking to [04] I confirmed that there was a teacher named [04] at the Sandy Hook Elementary School and confirmed that she had already been interviewed and provided a written statement detailing her involvement in and knowledge of the shooting at the school. I also confirmed that [04] was [04] and that she was expecting a visit from him on [04]

When [04] arrived in Connecticut, I advised him that since [04] had already provided a written statement, we did not need to interview him as we already had the information he had provided us from the source he cited.
