**ACTION TAKEN:**

On 06/17/13, I received a letter from a concerned citizen regarding Adam Lanza. The letter was addressed from Robert Braczyk [REDACTED] 03. Braczyk had concerns that Lanza had watched the movie "Looper", which premiered in September 2012. Braczyk stated that in the movie, a character played by Bruce Willis, shoots a young boy. Braczyk was concerned that Lanza had watched that part of the movie and was given the idea to shoot young children. On 06/18/13, I spoke to Braczyk via telephone. He indicated that he is a "movie buff" and recalled the scene in "Looper" after hearing about the Sandy Hook shooting. Braczyk had no further information to add.

On 06/18/13, I spoke to Det. Payette from Eastern District Major Crime Squad regarding their findings at the Lanza residence. Payette advised that there were no movie tickets or stubs located in the residence. Based on the lack of any ticket stubs, I am not able to determine if Adam Lanza had watched the movie "Looper".

**CASE STATUS:**

This case remains ACTIVE pending further investigation.

To Whom It May Concern:

This question may have already been asked and answered by someone in your organization. I pose it only on the chance that it has not come up.

Did Adam Lanza see the 2012 movie *Looper*? Please allow me to explain.

In that film, a character identified as Old Joe (Bruce Willis) travels back from the future to kill a child that he suspects will grow to become a crime boss who will one day kill Old Joe's wife. There are many twists in the plot but at one point Old Joe is in possession of the names of three boys, one of whom will grow to become this crime boss Cid. Old Joe intends to kill them all. In a brief scene he waits with a gun outside the house of one of the boys as the child comes home from school. The audience sees the boy arrive at his door. He turns innocently to face someone. Then they see Old Joe's face as he leaves the back yard of the house and know that he has killed the boy. You don't see the boy get shot or hear a gun, none-the-less, the scene is shocking. I can think of no instance in modern fiction where an adult shoots a child to death in cold blood. Maybe there are some but they are, I think, rare. The timing of *Looper* ( Premiered September 6, 2012) and the choice by Adam Lanza of children as targets is to me chilling.

I know that the CT State Police will soon be releasing their findings on the killings. It would, in my opinion, be important to know if there is evidence that shows that Adam Lanza had seen *Looper*.

I have sent a copy of this letter to CT Against Gun Violence.
