believed the photograph matched a male whom he had seen on 12/11/2012 at approximately 1900 hours while shopping at the Dick's Sporting Goods Store, located at the Danbury Fair Mall in Danbury, Connecticut.

As 04 watched, a group of four males approached the firearms counter, and at least one of the group members began talking to the clerk with whom 04 was dealing. The male told the clerk that they wanted to "look at guns to protect themselves against the end of the world."

The males continued to move around the area together, as a group. **104** described the males as Caucasian, 5' 09" to 5' 10" tall, dark hair, wearing "skater gear" – hoodies and jeans. **104** heard one of the males addressed as **104** but this was not the male who took the lead, speaking role; nor was it the male **104** suspected was Lanza. **104** described the males as all resembling one another; one pair resembled each other so closely that **104** believed them to be brothers – the male he identified as Ryan Lanza and one other.

The males also spoke with the store clerk about purchasing a crossbow bolt, and examined .22 caliber rifles and 12 gauge shotguns. When the males were advised of the two-week waiting period before they could obtain their firearms purchased, they responded with complaints and obscenities.
