Interview Report: 04

On Friday 12/14/2012, at approximately 1615 hours, Detective Pete Pinelli and I conducted an interview with witness, 04, who had reported he had seen a male he believed to be the shooter during a recent visit to Dick's Sporting Goods Store in Danbury, CT.

It is important to note that in media reports immediately following the event on 12/14/2012, several media outlets – including Fox News – misidentified the actual perpetrator, or his brother, Ryan Lanza. During these early reports, photographs of Ryan Lanza were shown. As 04 was unable to cite the specific media report he viewed, it is impossible to definitively determine whether the photo 04 referenced was either the shooter or Ryan Lanza. Throughout his statement, 04 alternates between the surnames of "Ryan" and "Adam." Due to this confusion, the names should be considered interchangeable within the context of this statement.

04 was interviewed at a picnic table located outside his residence at 03. Between the hours of 1635 and 1710 hours, I obtained a two-page sworn, written statement from 04 which contained the following information.

Earlier in the day, 04 had been watching a television news broadcast of the school shooting which had taken place at Sandy Hook Elementary School that morning. 04 was watching a FOX NEWS broadcast, which showed a photograph of a male they identified as Ryan Lanza.

04 believed the photograph matched a male whom he had seen on 12/11/2012 at approximately 1900 hours while shopping at the Dick's Sporting Goods Store, located at the Danbury Fair Mall in Danbury, Connecticut. 04 had been shopping for rifles and shotguns with his friend, 04

As 04 watched, a group of four males approached the firearms counter, and at least one of the group members began talking to the clerk with whom 04 was dealing. The male told the clerk that they wanted to "look at guns to protect themselves against the end of the world."

The males continued to move around the area together, as a group. 04 described the males as Caucasian, 5' 09" to 5' 10" tall, dark hair, wearing "skater gear" - hoodies and jeans. 04 heard one of the males addressed as "04" but this was not the male who took the lead, speaking role; nor was it the male 04 suspected was Lanza. 04 described the males as all resembling one another; one pair resembled each other so closely that 04 believed them to be brothers - the male he identified as Ryan Lanza and one other.

The males also spoke with the store clerk about purchasing a crossbow bolt, and examined .22 caliber rifles and 12 gauge shotguns. When the males were advised of the two-week waiting period before they could obtain their firearms purchased, they responded with complaints and obscenities.

04 and 04 left the sporting goods store before the other group. 04 later saw the males walking through the Danbury Fair Mall.
