**ACTION TAKEN:**

On 09/04/13, Det. Mudry received information from Lt. Michaels at Danbury Police Department regarding a possible lead in the Sandy Hook School shooting. On 09/05/13, I spoke to James Lasky from Novicky's Fireside in Brookfield regarding one of his employees, Kevin George. Lasky indicated that he hired George approximately 2-3 months ago. Lasky stated that recently George has been commenting on how he was interviewed by Newtown Police regarding the Sandy Hook School shooting. Lasky indicated that George stated that the police believed that he was the person running through the woods behind the school on the day of the shooting. Lasky also indicated that George stated that the police seized his guns as a result of the investigation.

On 09/05/13, I spoke to Detective Jowdy of the Newtown Police Department regarding George. Jowdy indicated that [REDACTED] 29 [REDACTED] Jowdy indicated that after the Sandy Hook School shooting, the neighbor complained that he believed that George may have had something to do with the shooting. Newtown Police Department opened a new investigation under case number 2013-00000243. As a result of their investigation, they were able to determine that George had no connection to the shooting [REDACTED] 29 [REDACTED] Jowdy provided me with the attached reports related to their investigation.
