Action Taken: On 6/10/13, this Detective spoke via telephone with [REDACTED] 03 04, regarding the ongoing investigation. During the conversation, [REDACTED] 04 relayed that when she heard about a recent bomb scare at one of the local Newtown schools, she felt compelled to share some details about some observations she noted on 12/14/12, [REDACTED] 04 relayed, in part, the following information:

That on 12/14/12, a friend of [REDACTED] 04 had alerted her to the shooting after hearing it on the news. [REDACTED] 04 explained that [REDACTED] 04, but that her friend had elementary school aged children, so [REDACTED] 04 responded to the area to stay with her friend's children until she could get there herself.

[REDACTED] 04 advised that she parked behind the Episcopal Church in the rear parking lot and walked through the woods to the Sandy Hook Firehouse where she remained for approximately a half hour until her friend arrived. [REDACTED] 04 stated that she walked back to her vehicle after clearing the Firehouse, and observed a vehicle that she felt was suspicious or out of place in a nearby driveway. [REDACTED] 04 explained that there is an abandoned white house near the church with "no trespassing" signs posted on the property, which has been there for years. [REDACTED] 04 stated that on that day she observed an older model dark colored Jeep Cherokee in the driveway at the time.

[REDACTED] 04 stated that she observed the driver to be a white male in his 20s inside the vehicle, and recalled thinking that the male had a look on his face that indicated fear. [REDACTED] 04 relayed that the male could have been there or affiliated with the house or the event in numerous ways, but that with the shooter deceased and therefore unable to provide any information, she wanted to relay what she had observed in the event that the male could
