SUPPLEMENTAL REPORT: NEWTOWN RESIDENTS - VICTIMS OF PRANK CALLS

ACTION TAKEN:

Throughout the course of December 14th, 2012 until December 21st, 2012 police personnel received several phone calls from Newtown residents. The residents stated that they have been receiving voice messages on their home phones stating "I am Adam Lanza and I'm going to kill you." All residents received these messages from phone number [REDACTED] 03. Some victims did call the number back and the male caller stated that he is Adam Lanza and he is going to kill them. With the assistance of the United States Marshall Service we were able to track the phone back to an individual in Venezuela. Venezuela authorities along with the United States Marshall Service are handling the investigation. The following is the list of victims:
