**ACTION TAKEN:**

Following the Sandy Hook Elementary School shooting on 12/14/12, the Connecticut State Police Western District Major Crime Squad was assisted in the investigation by several federal agencies to include the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). As part of the investigation, Special Agents from the ATF conducted firearms traces on all weapons owned by Nancy Lanza. The traces revealed six weapons to include:

- Bushmaster XM-15 .223 caliber rifle; serial number L534858; purchased by Nancy on 03/29/2010
- Glock 20SF 10mm pistol; serial number SMA461; purchased by Nancy on 01/05/2012
- Izhmash (IMEZ) 12 Guage shotgun; serial number H08402282; purchased by Nancy on 04/10/2010
- Enfield NO4MKI .303 caliber rifle; serial number HC22273A; purchased by Nancy on 10/09/2010
- Sig Sauer P226 9mm pistol; serial number UU676027; purchased by Nancy on 03/16/2011
- Savage Mark IIF .22 caliber rifle; serial number 1605038; purchased by Nancy on 10/26/2011

A copy of the ATF firearm traces are attached to this supplementary report.
