**ACTION TAKEN:**

On 12/26/12 at approximately 0830 hours, I received a teletype in the Troop A Major Crime mailbox with a note that [04] may have information related to the Sandy Hook Elementary School shooting incident which occurred on 12/14/12. The teletype was dated 12/20/12 and included a phone number for [04]

At approximately 1640 hours, I attempted to contact [04] at the number listed on the teletype. I spoke to [04] and advised him why I was calling. [04] took my phone number and indicated that he would relay the message to [04].

At approximately 2050 hours, I received a call on my cell phone from John Ives. Ives indicated that he is employed as a nurse at the Adirondack Medical Center, Colby Center for Psychiatry. Ives stated that he got a message from [04] advising him of my call. Ives stated that [04] is admitted as a patient in the facility. Ives stated that [04] suffers from psychotic episodes with delusional thoughts. Ives stated that he didn't believe [04] to be a credible source based on his psychiatric history.

On 12/129/12, I contacted the Adirondack Medical Center to confirm Ives employment. The Center confirmed that Ives is employed as a Nurse at the Colby Center for Psychiatry.

Based on Ives comments, [04] is being dismissed as a credible source of information.
