
Audio/Video Report

On Friday, December 14, 2012 the Connecticut State Police Central District Major Crime Squad (CDMCS) was requested to assist the Newtown Police Department and the Connecticut State Police Western District Major Squad with the scene processing of a school shooting. The incident occurred at the Sandy Hook Elementary School, located at 12 Dickenson Drive in the Town of Newtown, Connecticut. CDMCS was assigned to process the outdoor scene as well as conduct a survey of the vehicles parked in the parking lot.

During the course of the investigation, I was assigned to create a video recording to document the outdoor scene processing and to document the items of evidentiary value that were seized during this portion of the investigation. The video was created by utilizing a Connecticut State Police Central District Major Crime Squad issued "Sony" model HDR-CX110 Handycam and the video footage was recorded on a digital media card.

At the conclusion of the investigation, the digital media card was downloaded and the video was copied onto a Memorex DVD-R which was submitted to the State of Connecticut Department of Emergency Services and Public Protection Forensic Science Laboratory where copies of the video were reproduced. The original DVD-R's will be placed on file at the Central District Major Crime Squad Office, located at 294 Colony Street, Building #1, Meriden, Connecticut, telephone number (203) 630-5650. Copies of the DVD-R can be made upon request.

The digital media card was reformatted for future use and no longer contains the video captured regarding this incident.


