## ACTION TAKEN:

On December 17, 2012 requests for personal property from victims was being aggressively pursued by family members by way of support troopers, so as they could intern their loved ones with their personal effects. As such, a decontamination station was set up to clean heavily bio-hazardous soiled pieces of jewelry, ID badges, glasses and the like. As part of this process, various detectives and I took the attached digital pictures of all property in possession of the van detectives as received from the OCME, by way of Det. Mathew Greenstein. Each item released from the Van unit was accompanied by a JD-CR-18 and released from our collective custody to that of the family support trooper. In most cases the support trooper in turn had the representative family member sign a receipt of the property, and the copy was returned to the van. JD-CR-18 copies and originals were handled by Det. Sliby, the assigned evidence officer for the scene. See his detailed reported.

The photos were taken with my assigned Digital NIKON D300 SLR camera with a built in flash. A total of 30 images were taken. The photos were temporarily stored on a compact flash drive, until they could be burned to CD for long term archival. An original disk was burned forwarded to the State Police Forensic Lab Photography Unit, who remains the central repository for department photographic records.
